## AGENDA

1. Declarations of Interests and Dispensations

Mr Woods declared and interests in Item 8 - Planning Applications $16 / 02344$ and $16 / 02349$ as an adjacent landowner and was granted a dispensation.
2. Minutes of the previous meeting

The Minutes of the previous meeting were approved and signed.
3. Matters arising
a Play Equipment - following the accident on the climbing frame Mr Roberts had inspected the equipment and found it was safe to bring back to use.
b Queen's Birthday Commemorative Medals - $£ 28.40$ worth of medals had been sold on top of the free ones. Mr Nash would recover the VAT.
c Highways - the concrete slab near the entrance to Manor Orchard had not yet been fixed and the nearby drain was partially blocked.
4. Points from the public
a Mrs Cowdry raised the issue of the damaged verge opposite Moss Cottage.
b Mr Woods reported that he had been asked to raise:
$i \quad$ the erection of a mirror at the village entrance fingerpost at the Mixon. The Council declined to do this;
ii the erection of a "slow children" type sign. It was agreed to ask Wiltshire to erect a sign on the bank opposite Badgers.

## 6. Highways

- The Atkins Report for Wiltshire Council was considered to be inadequate and unrealistic.
- Notice had been received from Wiltshire of the closure of the road C60, seemingly for resurfacing, between Coate Hill and Gypsy/Shortlands Lane. No one could understand why this was being done as the surface was relatively good.

Councillors had attended the village open meetings at which full discussion had taken place. Everyone had supported vigorous objection to the proposals and many residents had lodged their personal objections with the Planning Officer, Mr Jonathan James.

Mr Woods was instructed to continue to take the Council's objections forward including taking external farming, legal and other advice. It was still not known when the Planning Committee hearing would be.

Mr Kernon's report that there was no farming justification for what was proposed and all the strong objections of the NWDAONB and CPRE were welcomed.

The Council expressed its thanks to Mr Woods for his hard work in this matter.
