1 **Appointment of Chairman and other Honorary Office Holders** Mr Woods was appointed Chairman and Mr Nash Treasurer and Responsible Officer (unpaid). Mr Woods was appointed unpaid Clerk. All proposed by Mr Smith and seconded by Mrs Bridewell and approved unanimously.

### 2 **Declarations of Acceptance of Office**

Mr Nash and Mr Woods declared their acceptance of office and the Code of Conduct.

- The safety repairs to The Mixon bus shelter had been completed as an emergency item. A letter of thanks from Mrs Robertson was tabled. Other passengers had asked Mr Woods to pass on their thanks and praise for the work done.
- Play equipment The Village Hall Social Committee had organised an enjoyable small get-together to express thanks to Bishops Cannings

Parish Council for paying for the equipment, donated to the Council, and to Mr Eric Clark for his support.

- HM Queen Elizabeth II's 90<sup>th</sup> Birthday Following the Council's agreement to purchase commemorative medals,Mr Woods had circulated a flyer to parishioners to request free and paid for medals.

## 11 **Reports of Meetings**

Highways – Mr Woods had attended a Wiltshire meeting in Devizes to learn about the new Highways arrangements. The key elements were that Ringway were replacing Balfour Beatty. They would cover most work though Tarmac would deal with the trunk roads. The popular Parish Steward scheme was being re-introduced but would not be fully operational until Ringway had trained up a full complement of staff. In view of continuing tight budgets not all work requested on the web-system replacing Clarence could be done, so staff would be prioritising action.

Area Board (16 May) –Mr Woods had attended. Councillor Whitehead had been appointed Vice-Chairman of the Area Board. Mr Woods had been invited to join CATG. Mr Whitehead had told Mr Woods that he had not yet heard the outcome of the Atkins survey of the All Cannings road and that the two planning applications by Manor Farm All Cannings had been withdrawn for amendment and were likely to be promulgated again by Wiltshire.

# 12 Planning Applications
